Applications are hereby invited from eligible Applicants from Indigenous inhabitants of Nagaland for filling up the post of Male Warder / Female Warder / Driver Grade-II under Prisons Department.

1. The recruitment for Male Warder / Female Warder / Driver Grade-II shall be held through Departmental Recruitment Board simultaneously as per the terms below.
  - (i) Applicants applying for the advertised posts of Male Warder / Female Warder / Driver Grade-II must be Class-VIII Passed from NBSE or Equivalent Qualification from other Board of School Education in India.
  - (ii) For the post of Male Warder / Female Warder, age of the applicant as on the date of issue of the advertisement, shall not be less than 18 (eighteen) years and not more than 38 (thirty-eight) years as per the existing Government Office Memorandum Dated the 26<sup>th</sup> February, 2024.
  - (iii) For the post of Driver Grade-II, age of the applicant as on the date of issue of the advertisement, shall not be less than 21 (twenty-one) years and not more than 37 (thirty-seven) years as per the existing Government Office Memorandum Dated the 15<sup>th</sup> October, 2024.

Serving Government employees applying for the advertised post should submit 'No Objection Certificate' issued by the concerned Head of Department along with Filled-in Application Form.
  - (iv) Reservation of seats for backward tribe will be followed as per the existing Government Notifications Dated the 14<sup>th</sup> April, 2011 and the 15<sup>th</sup> June, 2012.
  - (v) Application Forms attached with Particulars of Tests / Criterias can be downloaded from the Department's website <https://prisons.nagaland.gov.in> with effect from the 23<sup>rd</sup> May, 2025. The Filled-in Application Form attached with the complete self attested photocopies of the documents can be submitted on payment of ₹300/- (Rupees Three hundred) only as registration fees at the Directorate of Prisons, Nagaland, Kohima on or before the 9<sup>th</sup> June, 2025.

The Department shall not be responsible for the application submitted to any office or establishment other than the one mentioned above.

If any document is found to be forged / fake, the candidate will be summarily disqualified from the present and any future Recruitments in the Prisons Department.
  - (vi) The Applicants can check the rejected list with reasons on the Notice Board at the Directorate of Prisons, Nagaland, Kohima and the Department's website.
  - (vii) No TA / DA or any other remuneration shall be admissible to the applicants appearing in the Recruitment Rally / Tests at the designated venue(s).
  - (viii) The venue(s) and date for the Recruitment Rally and Tests will be notified at a later stage in the Department's website.
  - (ix) All selected Applicants shall be liable to serve anywhere in the State.
